

Abner, Herrman & Brock Named Top Guns Manager by Informa Investment Solutions

Jersey City, NJ - September 2017 - Abner, Herrman & Brock's Investment-Grade Taxable Bond Separately Managed Account (SMA) has been awarded a Top Guns designation and 6 star rating by Informa Investment Solutions' PSN manager database, North America's longest running database of investment managers.

Through a combination of Informa Investment Solutions' proprietary performance screens, PSN Top Guns ranks products in six proprietary categories in over 50 universes. This is a well-respected quarterly ranking and is widely used by institutional asset managers and investors. Informa Investment Solutions is part of Informa Financial Intelligence, a leading provider of critical decision-making solutions and custom services to financial institutions.

Top Guns firms are awarded a rating ranging from one to six stars, with the number of stars representing continued performance overtime. AHB was named a Top Gun with a star rating of 6 meaning products must have an R-Squared of 0.80 or greater relative to the style benchmark for the recent five-year period. Moreover, products must have returns greater than the style benchmark for the three latest three-year rolling periods. After that they select only the products which standard deviation for the five-year period is equal or less than the median standard deviation for the peer group. The top ten information ratios for the latest five-year period then become the TOPGUNS.

These results place us in the top quartile of the PSN MA Intermediate Fixed Income universe for the 1, 3 and 5 year periods.

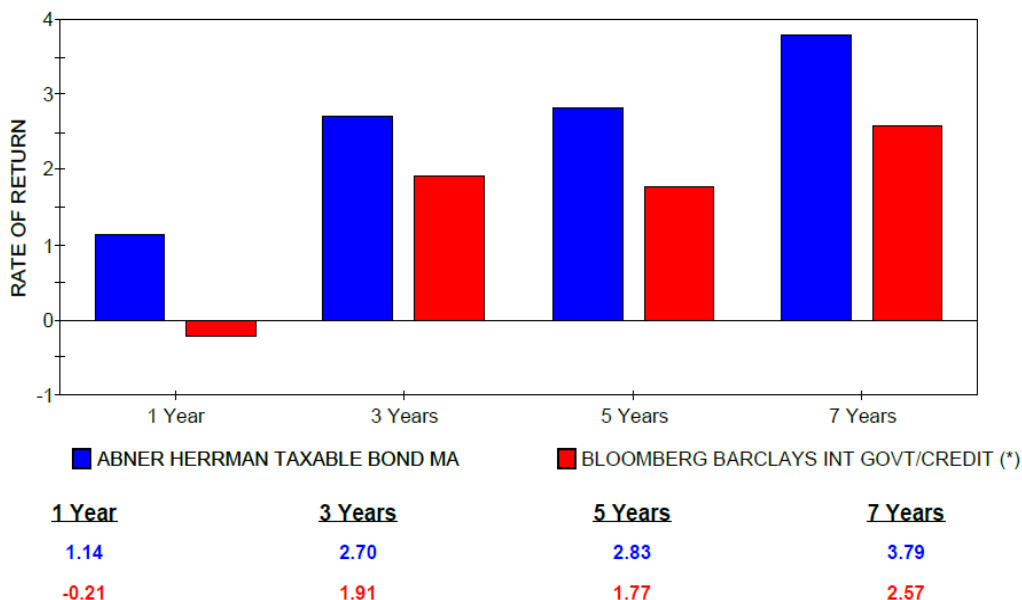
